BRANLEY A. ANDERSON, attest to the following, and state:

I am an Alaska State Trouper and on 12-28-87 at 0035 hours AST observed a 1986 Chevrolet driving on the Palmer Wasilla Highway. This vehicle was observed from mile 8 to mile 10.5. AST observed this vehicle weave from the shoulder to left side of the road, crossing the centerline by more than four feet. AT one point the vehicle crossed the cneterline with oncoming traffic and at another point the vehicle nearly hit the quard rail. AST stopped the vehicle and made contact with the driver who identified himself as William Brooks. Brooks had a strong odor of an alcoholic beverage on his breath. 4. Bill Brooks was unabble to perform any field sobriety tests in a satisfactory manner and could not repeat the alphabet nor could he do any balance tests. 5. Brooks stated that he had had four drinks at two bars.

6. Brooks was arrested on the scene and transported to Palmer jail where an intoximeter test resulted in a .143%BA.
